**Rear Admiral (Select) Garry J. Bonelli, Deputy Commander, Naval Special Warfare Command** RADM Bonelli enlisted in the Navy in 1968 and was a member of the first ever Underwater Demolition Team (UDT)/SEAL boot camp company. He made two, ground combat deployments in Vietnam as a Navy Frogman with UDT-12. In 1976, as a drilling Reservist, he completed his master of science degree in Mass Communications received a direct commission in the Navy Reserve. He has served as the commanding officer of eight Navy Reserve units. He was mobilized in 1990 in support of Operations *Desert Shield* and *Desert Storm*, and served as the commanding officer of SEAL Team 5. He has the distinction of being the first and only Reservist to ever command an active duty SEAL Team. In 2001, he was selected to serve as the Deputy Commander at Navy Reserve Readiness Command Southwest. Recalled to active duty again in 2006, he served as the Chief of Staff for Naval Special Warfare Command. Recalled again in 2007, he now serves as the Deputy Commander, Naval Special Warfare Command. # Legislative Update

## Senate Adopts Major Military Benefit Upgrades

The last week in September was a good week for the military community, as the full Senate approved a number of amendments including:

Majority Leader Harry Reid's (D-NV) amendment that would provide full, immediate concurrent receipt to disabled retirees deemed "unemployable" by the VA retroactive to January 1, 2005.

Sen. Bill Nelson's (D-FL) amendment that would accelerate 30-year paid-up Survivor Benefit Plan (SBP) coverage to October 1, 2007 and bar deduction of VA survivor benefits from SBP annuities.

Sen. Frank Lautenberg's (D-NJ) and Sen. Chuck Hagel's (R-NE) amendment that would bar any increases in TRICARE fees for FY2008 and articulate the sense of Congress that military health care is a crucial offset to the adverse conditions of service and that military people pay substantial premiums up-front in extended service and sacrifice over and above any cash fees.

Sen. Saxby Chambliss's (R-GA) amendment that would reduce the Reserve retirement age by three months for each 90 days served on active duty since 9/11/01.

Sen. John McCain's (R-AZ) amendment that would increase the maximum annual points creditable for Reserve component retirement to 130 points (vs. 90) for 2007 and subsequent years.

Sen. Norm Coleman's (R-MN) amendment that would authorize paying increased reimbursements for mental health care if required to meet needs, and requiring a Pentagon report on military beneficiaries' adequacy of access to mental health services.

Sen. Blanche Lincoln's (D-AR) amendment that would authorize Guard or reserve members to use their mobilization GI Bill benefits up to 10 years after separating from the Selected Reserve.

## Medicare, TRICARE Fixes Delayed

Earlier this year, the House passed the Children's Health and Medicare Protection Act, which, in addition to increasing coverage of lower-income children under Medicaid, would have reversed the 9.9% cut in Medicare/TRICARE payments to providers scheduled to take effect on Jan. 1 under current law. Instead, the bill proposed modest increases in doctor payments for 2008 and 2009.

This is a crucial issue, both for the elderly and for all military beneficiaries, since Medicare is one of the lowest-paying plans in America and TRICARE payments are tied to Medicare's. Today's payment rates are about what they were in 2001, while doctors' costs have risen significantly over the last 6 years. If payments are cut further, it will only lead more doctors to refuse to see Medicare and TRICARE patients.

MOAA had hoped that the children's health bill would be a vehicle for quick action on Medicare/TRICARE payments. Unfortunately, that didn't pan out.

The Senate equivalent bill did not include the Medicare/TRICARE payment fix, and congressional leaders decided to drop that provision in the interest of passing a "clean" bill on children's health coverage.

House and Senate leaders say they're still committed to preventing the cuts in doctor payments from taking place, and we believe they're serious. One big challenge is that reversing the payment cuts carries a price tag of \$20 billion over ten years. Everyone in Congress wants to make the fix, but finding the money to pay for it is another issue.

Unfortunately, the decision to drop it from the children's health bill probably means this crucial action will be put off until the very end of the year - again. The most likely scenario is that it will be rolled into some kind of "must pass" omnibus legislation, so leadership can threaten that legislators won't get home for Christmas unless they agree on the funding and pass it.

### **Joint Silver Strand Chapter/Navy League Dinner Aug 20**

VADM Ed Martin, USN (Ret) gave an outstanding talk on his experience as a POW for almost six years after being shot down near Hanoi by a surface to air missile while on a combat mission on July 9, 1967. He credited senior officers, especially Admiral Stockdale, for providing the leadership that helped POWs endure the harsh treatment by the North Vietnamese. He provided an interesting perspective on his recent return to the Hanoi Hilton as a museum, and statements of humane treatment of POWs made by the North Vietnamese. Seventy people attended the dinner meeting.

### **Annual Joint Chapter Luncheon September 15**

Congresswoman Susan A. Davis, Representing the 53<sup>rd</sup> District of California, was the guest speaker at the Annual Joint Chapter luncheon at MCAS Miramar Officers' Club attended by over 135 people. She serves on the House Armed Services Committee, the Education and Labor Committee, and the House Administration Committee. She has recently been chosen as Chair of the Personnel Subcommittee of the HASC, which presides over such issues as military health care, recruitment and retention, and military education. Her Defense and National Security initiatives in Congress include increasing spending on defense and homeland security, consistently supporting military pay raises and working to restore free and reduced-cost school meals programs for military families.



Congressman Davis discussed the current major issues facing the Congress and the need for a bipartisan approach to solving those issues. She said her experience as an Air Force wife overseas gave her a valuable perspective on the demands on military personnel and their families. She made a point of noting that she was the first politician asked to speak to the Joint Chapter luncheon and considered it an honor. She was recognized and thanked for her strong support of the military.
