## PRESIDENT'S MESSAGE

### CAPT Jim Cahill, USNR, Retired

Where do your national MOAA dues go? Part of your dues goes to legislative action at the national level to support and continue veteran's benefits and entitlements.

In mid April, MOAA council and chapter presidents, from all the 50 states and Puerto Rico, with members of the National MOAA staff, paid a visit to congress. Here, those from the individual states, meet with their representatives and senators and their staffs to discuss MOAA legislative initiatives. Silver Strand Chapter was represented by past president and current national board member, BG Wayne Hoffmann, AUS (Ret).

Focus was on three issues of concern. (1) H. R. 579 and S. 604, Tricare fee increases; (2) H.R. 1589 and S. 935, SBP (survivor benefit plan) inequities, and (3) H. R. 784 and S. 935, a larger pay raise for the troops than the 3% in the budget.

Most in congress expresses support and recent reports have

**Rear Admiral Patrick E. McGrath, Deputy Commander, Navy Region Southwest,** will speak at the joint Navy League/Chapter dinner on June 21. RADM McGrath began flight training at NAS Pensacola, FL in March 1980 and was designated as a Naval Aviator in April 1981. Upon completion of pilot training, he reported to his first fleet assignment with the HSL-35, making deployments to the Indian Ocean and Western Pacific aboard *USS Fanning*, *USS Reasoner*, and *USS Harry W. Hill*. He was then assigned to HSL-41 where he served as a flight instructor in the SH-60B Seahawk helicopter. He then was assigned to HSL-45, where he completed a deployment to the Persian Gulf aboard *USS Kinkaid* as Officer-in-Charge. He completed his Juris Doctorate in Law in 1991 at the University Of San Diego School Of Law. He left active duty in August 1990 and was commissioned in the Naval Reserves. His commands include: Commanding Officer of Naval Reserve Carrier Southwest Augment Unit 0294 and Deputy Commander, REDCOM Southwest. In his civilian career, he serves his community as a Deputy District Attorney in the San Diego District Attorney's Office.

# Legislative Update

**House Passes Defense Bill** The House of Representatives spent two days and approved more than 40 amendments before finally passing the FY2008 Defense Authorization Bill on Thursday, May 17, by a 397-27 vote.

Some of the amendments adopted would:

- Extend the military pay raise plus-ups (3.5% raise in 2008 and raises that are one-half percentage point larger than the average American's for 2009-2012) to also include uniformed members of the Coast Guard, Public Health Service and NOAA Corps (Rep. Drake, R-VA).
- Require increased family support and mental health services for National Guard and Reserve personnel (Rep. Braley, D-IA).
- Let employees who are family members of mobilized military personnel use family medical leave to deal with issues arising from that call to duty (Rep. Altmire, D-PA).
- Authorize Guard and Reserve members up to 10 years after leaving service to use GI Bill benefits (Rep. Carney, D-PA).
- Authorize vouchers for free mail delivery to military personnel in Iraq or Afghanistan or hospitalized in military facilities. (Rep. Altmire, D-PA/Rep. Udall, D-NM).
- Bar simultaneous deployment of both military parents to a combat zone when the military couple has minor dependents (Rep. LaHood, R-IL).
- Bar courts from changing child custody orders while a servicemember is deployed, other than temporary orders issued in the best interest of the child. Original custody order to be reinstated upon the member's redeployment (Rep. Turner, R-OH).

**Administration Opposes House-Passed Benefit Protections** On May 16 the White House Office of Management and Budget (OMB) fired off a letter to Congress expressing its displeasure with a number of pay and benefit improvements the House included in its version of the FY2008 Defense Authorization Act. Here's what OMB had to say on the following topics:

**Military Pay Raise:** The Administration "strongly opposes" the provisions that would provide active duty, Guard and Reserve personnel an extra one-half of one percent pay raise each year from 2008 through 2012. The OMB letter calls this small extra pay raise "unnecessary."

**TRICARE Fee Hikes:** OMB says, "The Administration is disappointed that the Committee language would not allow DoD to adjust TRICARE health fees and payments for retired military beneficiaries under age 65."

**Special Survivor Indemnity Allowance:** "The Administration opposes" the House proposal to establish a special \$40/month payment to survivors of members whose deaths were caused by military service and who now lose up to \$1,067 per month due to deduction of VA Dependency and Indemnity Compensation (DIC) from their military SBP annuities. "It appears to be the first step toward eliminating the offset between SBP and DIC," said the letter.

**Combat-Related Special Compensation:** The Administration "strongly opposes" the House proposal to extend CRSC eligibility to members who are forced into medical retirement with 15 to 19 years of service and who suffer combat-caused injuries rated as 60% or more disabling. MOAA has a hard time understanding any position that would refuse to "vest" such long-serving combat-wounded members in their service-earned retired pay - especially since the government already extended such vesting to thousands who were allowed to retire with 15-19 years' service during the force drawdown of the 1990s.

## **Tricare Emergency Facility Use Overseas**

Many military retirees occasionally travel outside the U.S. One concern is what medical coverage they have should care be required. There are a couple options available to you:

1. You can pay the bill then, when you return home, submit a claim to Tricare. The claim will be processed and paid in accordance with existing policy. Normal medical care needs are generally paid.
  2. If the required care involved going to an Emergency Facility, payment might be paid by Tricare directly to the facility. This can be done through a local contractor. The way to do this is:
    - a. Call (888)777-8343 the Tricare Overseas line. You will then be guided to a regional contact, who will assist you. This should be done as soon as possible.
    - b. Go online at [www.tricare4u.com](http://www.tricare4u.com) . This is a general information home site with links to Oversea/foreign departments etc. You can also obtain claim forms at this site.

## **Medicare Part D Disenrollment**

Some retirees have been surprised to find out they are enrolled in Medicare's pharmacy plan Part "D". This is generally the case when the military retiree or spouse belongs to a HMO because most HMOs automatically enroll Medicare eligible members in Part "D". The problem is that the military retiree can no longer get his/her prescriptions through Tricare and there is in some cases a significant amount of money involved.

If you find yourself in this position and would like to disenroll, call Medicare at (800) 633-4227. This number is also noted in the top right hand corner of your Medicare Card.

If you would like to know whether or not you are enrolled in Part "D," you can find out by calling Medicare or through the web at [www.Mymedicare.gov](http://www.Mymedicare.gov) . This site will require you to register, but it is easy to do. Note: While you are at the site, note the things you can do through it such as view or modify your drug list or pharmacy information, or get a replacement Medicare Card, etc.

shown an increase in the numbers of co-sponsors for the bills.

Part of your Cal-MOAA dues goes to support legislative action in California.

On the state level a bill that deserves our support is SB 111. California is the only state that does not help National Guard members with education. Forty-nine states offer National Guard members benefits such as free state university tuition and stipends of \$500 a semester. Officials say their surveys of guard members show that help with education would be the major reason to reenlist.

Attempts to get tuition assistance have been stalled in Sacramento and bills have died in the legislature because of budget short falls or opposition to the war in Iraq. Only 13 of the 120 in the assembly have had military experience and less than that on their staff.

Cal-MOAA will be actively pursuing ways to bring legislation forward to correct this inequity, you can also help. Your legislators in both the state and national offices will be on their summer recess soon, call their local office and request their support for these bills. All members of the Silver Strand Chapter of MOAA should be proud of the two NJROTC units we support, Coronado High School and Mar Vista High School.
